### **GM RECEIVES FAVORABLE IRS RULING ON HUGHES TRANSACTION**

**NEW YORK** - General Motors (NYSE: GM, GMH) today announced that it has received a favorable private-letter ruling from the U.S. Internal Revenue Service confirming that the split-off of Hughes Electronics from GM to facilitate the subsequent merger of Hughes with EchoStar Communications Corp. would be tax-free to GM and its stockholders for U.S. federal income-tax purposes.

General Motors, Hughes and EchoStar continue to seek required regulatory clearances and approvals from the U.S. Department of Justice and the Federal Communications Commission with a goal toward completing the transaction in the second half of 2002. The companies also are in the process of preparing materials to be distributed to GM and GM Class H stockholders seeking their approval for the transaction, and to EchoStar stockholders for their information.
