The Registrant has determined that additional time is needed to finalize its Annual Report on Form 10-K for the year ended December 31, 2004, and the financial statements for the year ended December 31, 2004 required to be included therein. Despite diligent efforts, work necessary to complete the Form 10-K, including complying with the internal control requirements of the Sarbanes-Oxley Act of 2002, could not be finished in sufficient time to permit the filing on the scheduled due date of Wednesday, March 16, 2005, without unreasonable effort and expense. The Registrant expects to file its Form 10-K within the 15 calendar day extension period provided by Rule 12b-25.

For the year ended December 31, 2004, the Registrant's net earnings were \$143.8 million, or \$2.24 per share - diluted compared to the \$254.4 million, or \$3.99 per share - diluted reported for 2003. For the three months ended December 31, 2004, the Registrant's net earnings were \$25.6 million, or \$0.40 per share - diluted compared to \$36.7 million, or \$0.57 per share - diluted, reported in the comparable 2003 period. These results were disclosed in press releases and in related Form 8-Ks dated January 27, 2005 and March 14, 2005 and filed with the Commission.
