**For the year ended December 31, 2004, the Registrant's net earnings were \$143.8 million, or \$2.24 per share - diluted compared to the \$254.4 million, or \$3.99 per share - diluted reported for 2003. For the three months ended December 31, 2004, the Registrant's net earnings were \$25.6 million, or \$0.40 per share - diluted compared to \$36.7 million, or \$0.57 per share - diluted, reported in the comparable 2003 period. These results were disclosed in press releases and in related Form 8-Ks dated January 27, 2005 and March 14, 2005 and filed with the Commission.**
