During the second quarter ended June 30, 2007, the Registrant completed the acquisition of a 51% ownership interest in ZAO Cortec and its subsidiaries (together Corbina), a Russian telecommunications company. Due to the acquisition and the time required to prepare the consolidated financial statements of Corbina in compliance with accounting principles generally accepted in the United States, the Registrant and its auditors require more time to complete the preparation and the annual audit of the consolidated financial statements of the Registrant. The Registrant anticipates filing its Annual Report on Form 10-K by March 17, 2008.
