This Schedule 13G (the Schedule 13G) is being filed on behalf of Sapling, LLC, a Delaware limited liability company (Sapling), and Fir Tree Recovery Master Fund, L.P., a Cayman Islands exempted limited partnership (Fir Tree Recovery), relating to shares of common stock of Argyle Security Acquisition Corporation, a Delaware corporation (the Issuer), purchased by Sapling and Fir Tree Recovery. Fir Tree Value Master Fund, LP, a Cayman Islands exempted limited partnership (Fir Tree Master), is the sole member of Sapling and Fir Tree, Inc., a New York corporation (Fir Tree), is the investment manager of both Sapling and Fir Tree Recovery.

- (c) Sapling may direct the vote and disposition of the 186,610 shares of Common Stock. Fir Tree Recovery may direct the vote and disposition of 86,866 shares of Common Stock.
