On November 16, 2006, John W. Rogers, Jr. notified Bally Total Fitness Holding Corporation (the Company) of his resignation from the Company s Board of Directors, effective immediately. Mr. Rogers resignation was not due to any disagreement with the Company. On November 18, 2006, the Board of Directors voted to reduce the size of the Board to five effective immediately prior to the Company s annual meeting of stockholders scheduled for December 19, 2006, by eliminating the vacancy in Class II created by Mr. John Rogers resignation. As previously disclosed, on October 22, 2006, the Board voted to eliminate the Class I directorship currently held by Mr. Steven S. Rogers effective upon the annual meeting of stockholders, which will further reduce the size of the Board to four at that time.

On November 18, 2006, the Board of Directors appointed Don R. Kornstein as Chairman of the Compensation Committee.
