- (1) Acquisition of 28,512 shares pursuant to Rule 16b-3 upon payout of 60% (51,840 units) of earned performance share award under shareholder-approved benefit plan. Of these 51,840 units, 28,512 units were paid in shares of Issuer stock, with the remaining 23,328 units paid in cash to cover the reporting person's tax obligations.
