INVESTING IN VIRAGEN, INC. COMMON STOCK INVOLVES A HIGH DEGREE OF RISK. SEE "RISK FACTORS" BEGINNING ON PAGE 6 OF OUR PROSPECTUS DATED MARCH 21, 2000 TO READ ABOUT FACTORS YOU SHOULD CONSIDER BEFORE BUYING SHARES OF OUR COMMON STOCK.

PLAN OF DISTRIBUTION

We are offering 107,729 shares of our common stock to Ladenburg Thalmann & Co. Inc. under the terms of this prospectus supplement. The common stock will be purchased at a negotiated purchase price of \$111,111. In addition, we will pay \$2,222 in commissions on the sale of our common stock to Thomas Systems, Inc., as the finder in connection with this transaction. We will also issue Ladenburg Thalmann a three (3) year warrant to purchase 7,541 shares of our common stock at an exercise price per share of \$1.33. We expect this transaction to close following this filing. We will not pay any other compensation in conjunction with this sale of our common stock in addition to the arrangements discussed in our prospectus dated March 21, 2000. We have agreed to indemnify the placement agent against liabilities, including liabilities under the Securities Act of 1933.

USE OF PROCEEDS

The net proceeds to us from this offering will be \$108,889. We plan to use the net proceeds for general corporate purposes, including:

- o funding of clinical trials of our Omniferon(TM) product;
- o funding collaborative research projects for the development of new technologies;
- o financing capital expenditures; and
- o working capital.

Pending use of the net proceeds for any of these purposes, we may invest the net proceeds in short-term investment grade instruments, interest-bearing bank accounts, certificates of deposit, money market securities, U.S. government securities or mortgage-backed securities guaranteed by federal agencies.

MARKET FOR OUR COMMON STOCK

On June 21, 2001, the last reported sales price of our common shares on the American Stock Exchange was \$1.18 per share. Our common stock began trading under the symbol "VRA" on April 17, 2000, on the American Stock Exchange.

As of June 21, 2001 and before the issuance of shares pursuant to this prospectus supplement, we had 99,300,168 shares of common stock outstanding.
