This Amendment No. 2 amends the Schedule 13D filed by Richard L. Scott (Reporting Person) on May 2, 2005 (the Schedule 13D), as amended May 15, 2006, with respect to shares of the Common Stock, \$.01 par value (Common Stock), of Amtech Systems, Inc., an Arizona corporation (the Issuer). Capitalized terms used but not defined herein shall have the respective meanings ascribed to such terms in the Schedule 13D.

The following Items are hereby amended and restated in their entirety to read as follows:

Item 3. Source and Amount of Funds or Other Consideration

The Reporting Person has used personal funds of approximately \$1,427,336.54 to acquire the 323,654 shares of Common Stock owned by the Reporting Person (including funds to acquire shares of Series A Preferred which have been converted to Common Stock). The shares were purchased by Amtech Investments, LLC, an entity controlled by the Reporting Person.

Item 5. Interest in Securities of the Issuer

On March 20, 2006, Reporting Person converted all 312,500 shares of Series A Convertible Preferred Stock owned by Amtech Investments, LLC, an entity controlled by the Reporting Person, to 312,500 shares of Common Stock.

The 323,654 shares of the Common Stock owned by the Reporting Person constitute 9.4% of the outstanding Common Stock of the Issuer based on the outstanding shares of Issuer Common Stock set forth on the Issuer's most recent Form 10-Q.

The Reporting Person has sole voting and dispositive power with respect to the Common Stock.
